### Respective responsibilities of the body and the auditor

This smaller authority is responsible for ensuring that its financial management is adequate and effective and that it has a sound system of internal control. The smaller authority prepares an annual return in accordance with proper practices which:

- summarises the accounting records for the year ended 31 March 2016; and
- confirms and provides assurance on those matters that are relevant to our duties and responsibilities as external auditors.

Our responsibility is to review the annual return in accordance with guidance issued by the National Audit Office (NAO) on behalf of the Comptroller and Auditor General (see note below). Our work does not constitute an audit carried out in accordance with International Standards on Auditing (UK & Ireland) and does not provide the same level of assurance that such an audit would do.

### External auditor report (ACCA0167)

On the basis of our review of the annual return, in our opinion the information in the annual return is in accordance with proper practices and no matters have come to our attention giving cause for concern that relevant legislation and regulatory requirements have not been met.

Other matters not affecting our opinion which we draw to the attention of the smaller authority:

The Annual Return was not accurately completed before submission for review. Please ensure that amendments are corrected in the prior year comparatives when submitting next year's Annual Return:

- The accounting basis was changed from cash to accruals this year and, when restating the prior year figures, the Box 8 figure was incorrectly restated. It should read £264,182.
- A Treasury Bond that was redeemed during the year had been accounted for twice, as a result the figures in Boxes 3, 7 and 8 all need to be reduced by £110 to £278,452, £611,392 and £604,363 respectively.

The cash book summary section of the bank reconciliation provided to support the Box 8 figure was incorrect. This section should reconcile from the prior year Box 8 to the current year Box 8 figure.
